### Welcome, declarations and minutes

- Kate Barclay welcomed the Committee and Institute officials to the meeting. The Chair asked Committee members whether they had any declarations of interest to make.
   Committee members confirmed that they had no interests to declare.
- 2. The Chair confirmed that a further Board member, Professor Malcolm Press, will be joining the Committee from 2019, to further strengthen the Committee's expertise.
- 3. The Committee considered the minutes from the last meeting on 1<sup>st</sup> November and were content with approving these.

## Proposals, standards and assessment plan recommendations

#### **Proposals**

4. The Committee reviewed the 10 recommendations on new proposals made by Route Panels as part of cycle 17. The Committee considered each of these proposals in detail and agreed with the Route Panel's recommendations on nine proposals. The following proposal was put on hold: • Clinical Academic Professional (Degree) (Level 8) (ST0706) - this is the first Level 8 proposal to be considered by the Institute and the Committee questioned whether this PhD level proposal qualified as an apprenticeship, whether it could be approved under current rules and whether it was in the spirit of apprenticeship policy. The Committee deferred a decision on this pending a discussion with the Institute Board.

# ACTION 1: The Clinical Academic Professional (Degree) (Level 8) proposal to be discussed with the Board at their next meeting in January.

#### Committee Sampling for Standards and Assessment Plans

- 5. As part of their regular sampling of a selection of occupational standards and assessment plans, the Committee looked in detail at all the standards and assessment plans in the Creative and Design Route. The Committee agreed with all the recommendations made by the Creative and Design Route Panel.
- 6. The Committee raised a concern in relation to the funding for Jewellery, Silversmithing and Allied Trades Professional apprenticeship, noting that a core and options standard it will be funded on the basis of the cost of the lowest option. They noted that this may cause issues in delivery where the materials costs vary significantly across the occupations in the same standard. The funding team will review this once the end-point assessment plan is submitted.
- 7. At the last Committee meeting in November, the Committee considered the proposal for the occupation of Through Life Engineering Services Specialist, and raised concerns that it represented a programme of learning related to an existing Masters course, rather than a legitimate occupation. However, they accepted the Panel's recommendation that it did represent an occupation and agreed the proposal, subject to it returning to the Committee for agreement of the standard.
- 8. The standard for the occupation of Through Life Engineering Services Specialist was considered by the Committee at this meeting as part of its sampling strategy. The Committee agreed with the Panel recommendation to agree the standard. However, they noted concerns that the increasing number of degree apprenticeships, particularly at Level 7, may put pressure on funding for delivery of apprenticeships at the lower levels, while cross-subsiding higher education from the apprenticeship budget. They asked for a Board

discussion of this issue (alongside consideration of the proposal for a Level 8 apprenticeship). A separate paper will be presented to the Board setting out these issues.

ACTION 2: The Institute's Policy Adviser to prepare a paper for the Board setting out the issues/concerns raised by the Approval and Funding Committee around Level 7 and Level 8 apprenticeships for a wider discussion at the next Board meeting.

### Returned Occupational Standards and End Point Assessment plans

- 9. The Committee considered standards and assessment plans that were recommended to be returned to trailblazer groups. The Committee agreed with the route panel decisions to return the following standards and assessment plans to trailblazer groups:
  - Pharmacy Technician (ST0300) standard was returned as the standard was heavily
    focused on the retail aspects of the occupation, the knowledge, skills and behaviours
    did not fully align with the occupational profile and that the standard as currently
    drafted would not provide full occupational competence.
  - Aerospace Software Development Engineer revision (ST0013) standard was returned as it is not sufficiently distinct from the Digital and Technology Solutions Professional standard published in the Digital Route, something that was also noted by the Digital Panel when they were sent the standard for comment. Both panels recommend the trailblazer group engages with the Digital standard trailblazer group to explore the possibility of amalgamating the two standards. If that is not possible, the Aerospace standard needs to be revised to include significantly more sector and/or technology specific content to demonstrate it is a distinct occupation.

# **Funding Band recommendations**

- 10. The Committee considered and made recommendations on final funding bands for the following 23 apprenticeship standards:
  - ST0767 Water Environment Worker
  - ST0663 Employability Practitioner
  - ST0708 Public Sector Compliance Investigator/Officer
  - ST0694 Career Development Professional

- ST0146 Assessor Coach
- ST0148 Learning Mentor

- 11. The Committee considered each of these in detail including the views of the Route Panels. The Committee agreed with the route panels that two recommendations should not be approved:
  - Tramway Construction Operative (Level 2). The Committee agreed with the route panel that there wasn't sufficient evidence to justify the recommended funding band.
  - Clinical Coder (Level 3). The Committee agreed with the route panel that there was not sufficient evidence to justify the recommended funding band.
- 12. The Committee did not approve one further recommendation:
  - Materials Process Engineer Master's Level (Level 7). The Committee considered
    the recommendation to be too high. They asked the funding team to speak to the
    Trailblazer to better understand what training would be required over and above the
    Master's qualification.

- 13. In addition, the Committee made a further request on a funding band recommendation which they were content to approve:
  - Specialist Rescue Operative (Level 4). The Committee asked the Institute to feed
    back to the Department for Education that entrants to this apprenticeship could be
    expected to have prior learning, which would reduce the training cost. The
    Department will want to consider how it monitors this.
- 14. The Committee also asked for the Funding Team to provide them with an update at the next meeting in February on work to consider feedback that that funding band allocation process is not sufficiently transparent.

ACTION 3: The Funding Team to provide the Committee with an update on transparency of funding band decisions at the next Committee meeting in February.

#### **T-Level recommendations**

- 15. The Committee were presented with an overview of the T-level submissions for cycle 17. This included the final outline content for Onsite Construction which the Committee were content to approve. They were informed that the outline content for Building Services Engineering has been deferred as there were a number of areas that needed further work. It will be resubmitted in a later cycle.
- 16. The final outline content was also submitted for Digital Support Services. The Committee were content with the Route Panel's decision to reject the outline content based on the fact the T Level panel had moved away from the agreed structure of T Levels and designed a mandatory 'Digital Infrastructure' specialism, which would make it difficult to achieve threshold competence.
- 17. The Committee will be provided with further guidance at a future meeting on their role with regards to the approval of the T Level qualification and which elements they will need to consider.

# Consistency and quality across end-point assessments

18. Members of the Assessment and Quality Assurance Team provided the Committee with

an update on how the Institute considers the burden of assessment on apprentices and

its approach to ensuring consistency across assessment plans.

19. The update outlined the eight steps the team takes when analysing assessment plans

and the methods of analysis they use.

20. Each plan is subjected to a rigorous process against assessment and occupational

knowledge that leads to robust, valid and fair assessments.

**Lessons Learnt Review** 

21. Members of the Funding Team confirmed that the lessons learnt report for the

Advertising and Media Executive standard had now been completed and that a diagram

of how to handle similar situations in the future was being developed. This will be shared

with the Committee once it is available.

2019 sampling schedule

22. Prior to the meeting, the Committee Chair had shared with Committee members a draft

sampling schedule for 2019 for their comments. Committee members confirmed that

they were happy with the proposed schedule and indicated that they would prefer to

sample standards and end-point assessment plans by either route or level going forward.

The Committee also asked whether it would be possible to sample funding band

recommendations in the future.
