#### Welcome, declarations and minutes

- Kate Barclay (Chair) welcomed Committee members and Institute officials to the meeting.
   Apologies were received from Bev Robinson and Malcolm Press. Jessica Leigh Jones joined the meeting as an additional Board member voice. It was noted that Kate Barclay, Malcolm Press and Robin Millar had all reviewed and provided comments on the cycle 22 submissions ahead of the meeting.
- The Chair asked Committee members whether they had any declarations of interest to make.
   Committee members confirmed that they had no specific interests to declare.

- 3. Members heard that the Institute had launched two Route reviews, on Hair and Beauty and Creative and Design. An 8 week consultation for this had commenced and the Approvals team will return to the A&FC on early findings in due course.
- 4. Members noted that there had been a Board discussion in relation to the quality of Standards, and issues identified included overlap and number of returns.
- 5. It was noted that Cycle 23 would include draft outline content for a number of Routes, including (1) Engineering and Manufacturing, (2) Catering, (3) Hair and Beauty and (4) Business Administration.
- 6. The Committee considered the draft minutes from 20 June meeting and agreed that these were an accurate reflection of discussions.

ACTION 1: Members requested early cite of papers in Cycle 23 due to the projected heavy work programme. Officials to submit meeting papers at least 10 days prior to the meeting.

#### **Current approvals process**

#### Occupation Proposals

- 7. The Committee reviewed 11 recommendations on new occupation proposals made by Route Panels in Cycle 22. The Committee agreed with all the recommendations made by the Route Panels.
- 8. The Committee agreed a further condition in relation to 'Domestic Violence and Abuse Advocate' (Proposal); in that the title is amended to provide greater clarity on the nature of the role. In addition the Committee requested the proposal seek to have coverage across children and adults settings and be able to recognise both pathways.
- 9. In relation to L4 Early Intervention (Proposal), the Committee requested that the title is amended as it is currently nonspecific. In addition, the Committee requested the expansion of the trailblazer group to ensure cross-sectoral contribution and traction.
- 10. The Committee requested that the trailblazer group for L5 Embalmer be expanded to incorporate small and large organisations to ensure a wider representation of the sector. The Committee addition agreed to consider L5 Embalmer at Standard stage.

#### **Committee Sampling of Standards & Assessment Plans**

11. As part of routine sampling, the Committee looked in detail at all level 4 and 5 submissions across all routes. The Committee agreed with the recommendations made by the Route Panels. They discussed the naming of the DevOps Engineer standard and asked whether the group could reconsider the naming so that it was future proofed, and they were content the that Digital route review had been taken into consideration when this standard was discussed. The Committee were also content that the End-point assessment plans were robust. The Committee requested that the assessment team provide the A&FC members some training, to include showing them the guidance for Trailblazers and apprentice builder, and some explanation of assessment.

## ACTION 2: The Quality and Assessment team to deliver a teaching session on EPA to A&FC members ahead of the 12<sup>th</sup> September meeting.

12. There were no returned standards and assessment plans for the Committee to consider.

#### **Funding Band Recommendation**

13. The Committee reviewed 12 funding band recommendations and agreed with the Route Panels on all recommendations. Two of these: ST0207 Advanced Golf Greenkeeper and ST0208 Golf Course Manager were indicative funding bands as the trailblazer group opted to remain in the old funding band allocation process.

#### T Level Content

14. The Committee were presented with four Outline Content Structures Submissions:

#### Engineering & Manufacturing

- Manufacturing, Process & Control
- Maintenance, Installation & Repair

#### Agriculture, Environment & Animal Care

- Animal Care & Management
- Agriculture, Land Management and Production

15. The Committee were content to agree the outline content structures with the conditions set out by the Route Panels. However, they elected to re-include the condition on the viability and demand for the sports turf specialism. The Committee had an in-depth discussion about T Levels, particularly centred on the Maintenance, Installation and Repair pathway, and whether learners would be able to be "work ready" in the relevant occupations following two years of classroom based study, given the very practical nature of these occupations. The committee requested that in future meetings they would like to focus on having a detailed discussion of T Levels on a selected pathway.

#### **Funding Analysis**

16. The committee noted the funding analysis and agreed it was helpful to see starts figures for each standard. In future meetings the funding analysis paper will be presented for information.

#### **AOB**

- 17. Officials informed the A&FC that the Institute was in the second phase of the funding improvement programme, and requested on-going support as this work progresses.
- 18. The next meeting of the Approval & Funding Committee will convene on Thursday 12 September 2019, from 14:00 16:30 in Room 1 at 151 Buckingham Palace Road.
