#### **APPROVAL & FUNDING COMMITTEE**

Meeting Title Approval & Funding Committee - 20 June 2019

#### Welcome, declarations and minutes

- Robin Millar (Acting Chair) welcomed Committee members and Institute officials to the
  meeting. Apologies were received from Kate Barclay and Bev Robinson but Paul Cadman
  joined the meeting as an additional Board member voice. It was noted that Kate Barclay,
  Malcolm Press and Robin Millar had all reviewed and provided comments on the cycle 21
  submissions ahead of this meeting.
- The Chair asked Committee members whether they had any declarations of interest to make.
   Committee members confirmed that they had no specific interests to declare.
- 3. The Committee considered the draft minutes from 9 May meeting and agreed that these were a true reflection of discussions.

### **Occupation Proposals**

4. The Committee reviewed 11 recommendations on new occupation proposals made by Route Panels in Cycle 21. The Committee agreed with all the recommendations made by the Route Panels including returning the following proposals back to trailblazer group.

**Business Support Assistant (L2 - Proposal)**, was returned as it did not meet the minimum criteria for an apprenticeship, is not a stand-alone occupation or skilled enough to provide full occupational competence.

**Temporary Traffic Management Operative (L2 - Proposal)** was returned as there remains insufficient evidence to justify a year's worth of technical training with 20% off the job, and the duties do not clearly meet the requirements of Level 2.

Members requested information on likely apprenticeship entry requirements in the documentations.

#### **Committee Sampling of Standards & Assessment Plans**

6. As part of routine sampling, the Committee looked in detail at Education and Childcare Route.

The Committee agreed with the recommendation made by the Route Panel.

#### **Returned Standards and Assessment Plans**

7. The Committee reviewed returned Standards & Assessment Plans. They agreed with all recommendations made by the Route Panels with exception of Broadcast and Media Systems Technician (Level 5) which they approved with conditions. They also recommended that Route Panel review the final version of the Plan. Returns are detailed below:

**Chartered Surveyor (Standard – L6)** was retuned as 3 of the 4 options were not sufficiently distinct from each other & the fourth option was not sufficiently distinct from Construction Quantity Surveyor standard.

Non-Home Office Police Officer (Standard – 3) was returned as it did not meet the criteria for full occupational competency. Content is too generic and in particular, the specialist options need further development to sufficiently cover the skills and knowledge required

**BEMS Controls Engineer (Assessment Plan – 4)** was returned as further clarity required on specialist topic areas. In relation to the observation the Panel wanted to see and approve the tasks to be included within this assessment method to ensure they were appropriate.

**Storyboard Artist (Assessment Plan – 7)** was returned as further work was required to ensure that the End Point Assessment is robust enough and meets the requirement of other level 7 programmes.

#### **Funding Band Recommendations**

8. The Committee reviewed 11 funding band recommendations and agreed with Route Panels on 9 of them.

#### T Level Content

- 10. The Committee were presented with recommendations on Wave 1 TQs:
  - **Digital:** Digital Production, Design and Development Pathway (Pearson)
  - Education: Education and Childcare pathway (NCFE)
  - **Construction:** Design, Surveying and Planning pathway (Pearson)
- 11. It was agreed that the feedback from the Committee on the aforementioned recommendations will be taken forward to the TQ Board meeting for discussion on sign-off of wave 1 for these routes. The Committee was also content to agree the recommendations of the Engineering & Manufacturing and Catering & Hospitality outline content structure proposals as recommended by the Route Panels.

- 12. The Committee heard that the Quality Assurance Committee also considered T Levels (assessment content) at a recent meeting and that QAC had undertook to monitor awarding organisations to ensure that trajectory progress was being made towards milestone 2.
- 13. The Committee requested that data on T Level drop-outs is collected from the outset in order to better understand trends and enhance decision making.

#### Analysis of funding bands

- 14. The Committee reviewed a paper regarding the differentials in funding between small routes and all standards approved by the Institute. This paper concluded that the shorter duration of the standards in small routes may account for the lower levels of funding. The Committee felt that in future, additional information such as the number of starts and completions on standards would be useful additions to the regular funding analysis papers they see.
- 15. The Committee also revisited its interest in better understanding the materials costs associated with different apprenticeships. To further strengthen this area, the Funding team are working with trailblazers at an earlier stage (through funding workshops) to ensure relevant information is included in the quotes.
- 16. Members were reminded that capital or depreciation/maintenance costs are not eligible for levy funding .
- 17. Ahead of the September Board meeting the Funding team will circulate a funding paper to AF&C for comment.

# ACTION 1: Funding Team to develop paper for the Approval & Funding Committee's comments ahead of the Institute Board meeting on 18<sup>th</sup> September.

18. The Committee received an update in relation 'action point 1' from the previous meeting on consistency of end –point assessment (EPA). The Committee heard that the review on the consistency of EPA is being undertaken internally and a paper will be presented to the Committee at its August meeting.

ACTION 2: Assessment and Quality Team to provide a written paper to the August Committee meeting on consistency of EPA.
