## Welcome, declarations and minutes

- Kate Barclay (Chair) welcomed Committee members and Institute officials to the meeting. Apologies were received from Malcolm Press. It was noted that Kate Barclay, Bev Robinson, Robin Millar and Malcolm Press had all reviewed and provided comments on cycle 23 submissions ahead of the meeting.
- The Chair asked Committee members whether they had any declarations of interest to make. Committee members confirmed that they had no specific interests to declare.
- 3. The Committee considered the draft minutes from 1 August 2019 meeting and agreed that these were an accurate reflection of discussions.



#### **Current approvals process**

#### Occupation Proposals

- 4. The Committee reviewed 16 recommendations on new occupation proposals made by Route Panels in Cycle 23. The Committee agreed with all the recommendations made by the Route Panels with the exception of VfX/CG Supervisor which was returned.
- The Committee considered the L7 Senior People Professional in detail and raised issues around distinctiveness. This was flagged for an early review as part of the Route Review.

#### Committee Sampling of Standards & Assessment Plans

6. As part of routine sampling, the Committee looked in detail at all the submissions in the construction route. The Committee agreed with the recommendations made by the Route Panel. The Committee noted that the Plasterer Level 2 Assessment Plan was very robust and contained the same number of assessment methods as the Level 3 Curtain Wall Installer and wanted to ensure that the appropriate level of assessment was being applied at each level. The Committee were informed that this was commensurate with L2 Bricklayer.

#### Clinical Academic Professional (Level 8)

7. The Committee expressed concerns about whether this occupation meets the criteria for an apprenticeship, in particular the inclusion of a PHD. In addition, the Committee believed that it did not meet the criteria for an apprenticeship



Standard. The Committee noted that further discussions were ongoing on this issue in conjunction with the Department for Education.

## **Funding Bands Recommendation**

8. The Committee reviewed 11 funding band recommendations and agreed with the Route Panels on all recommendations.

## **T Level Content**

## T-level recommendations

- 9. The Committee had a detailed discussion about their role in approving T-levels in general and the level of information that is submitted for them to review. They agreed that going forward they would look at the outline structure and the final outline content, with the main issues highlighted for their attention. They will not need to look at the draft outline content nor the entire final outline content documentation.
- 10. In addition, the Committee discussed threshold competence at the completion of T Levels.
- 11. The Chair confirmed that she will continue to represent the Committee at the Technical Qualification (TQ) Boards.
