Welcome, declarations and minutes

- Kate Barclay (Chair) welcomed Committee members and Institute officials to the meeting. Apologies were received from Robin Millar. It was noted that Kate Barclay, Bev Robinson, Robin Millar and Malcolm Press had all reviewed and provided comments on cycle 24 submissions ahead of the meeting.
- The Chair asked Committee members whether they had any declarations of interest to make. A declaration was made by Malcom Press in relation to ST0470: L6: Digital User Experience (UX) Professional (Integrated Degree) -Funding Band; it was thereby agreed that Malcom would leave the room whilst the funding band is discussed. Committee members confirmed that they had no other interests to declare.

4. The Committee approved the draft minutes from 1 August 2019 meeting with no amendments.

T Level approach

- 5. The Committee heard that the Institute was now at the Milestone 2 submissions stage for Wave 1 T Levels. This means Awarding Organisations have submitted their first full drafts. At the previous meeting it was agreed that the Committee would focus their attention on the outline content structure submission for each pathway. This is the first stage of developing the outline content when the occupations in scope of the T Level are decided. The Committee will then receive summaries of the draft and final outline content.
- 6. When the Awarding Organisations are developing the TQs, the Committee will also receive a summary of the most salient information. In addition it was agreed that the Chair would be briefed separately for the Technical Education Board. The Committee was content with this approach going forward.



Current approvals process

a) Proposals, standards and assessment plan recommendations

- 5. The Committee reviewed 12 recommendations on new occupation proposals made by Route Panels in Cycle 24. The Committee returned the Chartered Forester (L6) and Chartered Arboriculturist (L6) standards as they were not of the view that they should constitute two separate apprenticeships due to the degree of overlap, and felt further consideration should be given to core/option pathway.
- 6. In relation to Nuclear Technical Specialist (ST0779), the Committee agreed with the recommendation from the Engineering and Manufacturing Route Panel, but noted that mandating the PhD should be omitted.
- 7. In relation to Knitting Technican (ST0910), the Committee agreed that the Trailblazer should reconsider the titling to capture the engineering aspect.

Committee Sampling of Standards & Assessment Plans

- 8. As part of routine sampling, the Committee looked in detail at all level 2 and level 3 submissions. The Committee noted that the Gas Network Operative Level 2 Assessment Plan was very robust compared to Landscape Technician Level 3. However, they were content with the assessment methods given the safety critical elements required of the Gas Network Operative role.
- Going forward the Committee agreed that it would look at trend data instead of carrying out a sampling exercise on the submissions. The Insituite would provide data packs to Committee members to facilitate this exercise.



b) Funding band recommendations

- The Committee reviewed 10 funding band recommendations. Due to technical issues, the Committee was not given advance sight of ST0762: L4 Information Manager, so consideration of this funding band will be considered out of cycle.
- 11. The Committee agreed with the route panel decsion on 6 recommendations. They also supported the route panel's decision to request more information from the trailblazer for ST0783: L3 Costume Performance Technician before taking a decision on funding.
- 12. For two standards, ST0802: L3 Curtain Wall Installer and ST0470: L6 Digital User Experience (UX) Professional (Integrated degree) the Committee supported the funding team's original recommendation in both cases.
- 13. The Committee did not agree the funding band for ST0763: L7 AI Data Specialist. They were not convinced that the evidence presented supported the recommended funding band and asked the team to seek additional quotes from the trailblazer.

Review of qualifications criteria with Level 8

14. The Committee raised concerns regarding the inclusion of PhD's as part of Level8 apprenticeships. The Committee viewed that PhD's are about generation ofnew knowledge, not depth and breadth of existing knowledge.
