1. Welcome, declarations and minutes

 Kate Barclay (Chair) welcomed Committee members and Institute officials to the meeting. Apologies were received from Malcolm Press. It was noted that Kate Barclay, Bev Robinson, Robin Millar and Malcolm Press had all reviewed and provided comments on cycle 25 submissions ahead of the meeting.

2. Minutes Sign-off

- 3. The Committee approved the draft minutes from the 24 October 2019 meeting with no amendments.
- 4. The Chair asked Committee members whether they had any declarations of interest to make. The Committee had no further declarations of interest.

3. Current approvals process

Occupation Proposals

- 5. The Committee reviewed 15 recommendations on new occupation proposals made by Route Panels in Cycle 25. The Committee agreed with all the recommendations made by the Route Panels with the exception of Junior Advertising Creative which was put on hold pending a further conversation with the trailblazer.
- In relation to L6 Electro-mechanical Engineer (degree app) (proposal), it was agreed to flag this as part of the route review, specifically at the occupational map stage.
- 7. In relation to **L5 Payroll Assistant Manager**, the Committee agreed to reconsider this at Standard stage.
- 8. The Committee placed a further condition in relation to **L3 Anti-Social Behaviour Officer**, for the title to be amended.



 The Committee requested that the title of L3 Officer of the Watch is amended to enhance the clarity of the role. The Committee favoured the term 'Near Coastal Officer of the Watch'.

Standards and End-Point Assessment Plans (EPA).

10. As the Committee had previously agreed to cease the sampling of Standards and End-Point Assessment Plans; they noted and were content with the named Standards and EPA featured in the consolidated pack.

Funding band recommendations

- 11. The Committee considered 14 business as usual final funding band recommendations in Cycle 25. They agreed with the panel recommendation for 12 of them. The Committee agreed that there was insufficient evidence to support the route panel's proposed increase to the funding recommendation for two (ST0825: DevOps Engineer and ST0763: Al Data Specialist), and instead approved the funding manager's recommendation.
- 12. The Committee also considered the last funding band recommendation from Stock Review 2 (ST0340: Travel Consultant), which was previously appealed. They approved the panel recommendation.
- 13. The Committee did not consider **ST0926: Countryside Ranger**, due to the changes the route panel recommended to the Standard, and the possible effect this could have on the recommended funding band.
- 14. In relation to L7 Systems Thinking Practitioner and L7 Artificial Intelligence

 Data Specialist, the Committee requested early reviews to consider the uptake.



T Levels Content

15. The Committee noted the slides in relation to the update on T Levels.

Route Overview Report

- 16. The data science team delivered a presentation focussing on contextual data in relation to apprenticeships; the purpose for this is to further enhance the Committee's decision making process. Areas considered included development time, cumulative starts, demographics and provider markets.
- 17. The Committee welcomed the trend data, which they noted would support their governance role. The Committee also requested data on skills shortages and occupational demand. It was agreed that data reports will be submitted to the Committee on a quarterly basis.


