### 1. Welcome, declarations and minutes

 Kate Barclay (Chair) welcomed Committee members and Institute officials to the meeting. It was noted that Kate Barclay, Bev Robinson, Robin Millar and Malcolm Press had all reviewed and provided comments on cycle 26 submissions ahead of the meeting.

## 2. Minutes Sign-off

- 3. The Committee approved the draft minutes from the 5 December 2019 meeting with no amendments.
- The Chair asked Committee members whether they had any declarations of interest to make. Robin Millar declared a declaration, through his involvement in developing the ST0944 Assistant Sound Engineer proposal.

# 3. Current approvals process

# **Occupation Proposals**

- 5. The Committee reviewed 13 recommendations on new occupation proposals made by Route Panels in Cycle 26. The Committee agreed with 10 of the recommendations made by the Route Panels and returned a further 3 proposals; Assistant Recording Engineer, Audiovisual Technician & Medical Statistician. This was due to Committee concerns on the proliferation of standards.
- 6. In relation to **ST0943 L2 Dog Grooming Assistant** the Committee sighted the existence of the Equine Groom (ST0166) and indicated that an animal grooming Standard with core and options would be more beneficial.
- 7. In relation to **ST0860 L7 Asset Management Professional**, the Committee requested sight of the Standard once it is developed.
- 8. In regard to **ST0779 L8 Nuclear Technical Specialist**, the Committee reiterated concerns regarding the potential inclusion of a PhD. The Committee requested to view the Standard once developed.



## Standards and End-Point Assessment Plans (EPA).

 As the Committee had previously agreed to cease the sampling of Standards and End-Point Assessment Plans; they noted and were content with the named Standards and EPA featured in the consolidated pack.

# **Funding band recommendations**

- 10. The Committee considered 14 business as usual final funding band recommendations in Cycle 26. They agreed with the panel recommendation for 12 of them. The Committee agreed that there was insufficient evidence to support the route panel's proposed increase to the funding recommendation for one (ST0865 Cyber Security Technician), and instead approved the funding manager's recommendation.
- 11. The Committee did not approve the recommendation for ST0830 L7 Health and Care Intelligence Specialist, which they felt was too high. The Committee asked the funding team to gather additional evidence and reconsider.
- 12. In relation to **ST0831** L7 Historic Environment Advisor and **ST0865** L3 Cyber Security Technician; the Committee requested early reviews and consideration of take-up levels.

13. The Committee noted the slides in relation to the update on T Levels.

14. The Committee agreed with the recommendation to remove the Unified Communications Technician specialism from the Wave 2 Digital Support and Services T Level.
