1. Welcome, declarations and minutes

- III. The committee approved the draft minutes from the 2 July 2020 meeting with no amendments. The Chair revisited the status of previous actions and noted that these had been actioned.
- IV. The Chair asked committee members whether they had any conflicts of interest to declare. The committee was satisfied that there was conflict of interest were declared, including in connection with the content of the meeting. IX. The committee reviewed eight recommendations on new occupation proposals made by route panels in cycle 30. The committee agreed with seven of the recommendations and returned ST0957 (L7) Spatial Data Specialist.

Funding Summary

- X. The committee considered ten final funding band recommendations and one recommendation to postpone a decision until next cycle. The committee agreed with the ten funding recommendations. In relation to ST0901 VFX Supervisor, the committee requested the Institute to consider securing any additional evidence and bring the recommendation back in cycle 31.
- XI. In relation to ST0906: L3 Youth Support Worker, the committee requested an early review to consider the levels of take up/starts.
