1. Welcome

 Bev Robinson (acting Chair) welcomed committee members and Institute officials to the meeting. Apologies were received from Kate Barclay. It was noted that Bev Robinson, Malcolm Press and Paul Cadman had all reviewed and provided comments on cycle 31 submissions ahead of the meeting.

2. Minutes and Declarations of Interest

- II. The committee approved the draft minutes from the 10 September 2020 meeting with no amendments. The Chair revisited the status of previous actions and noted that these had been actioned.
- III. The Chair asked committee members whether they had any declarations of interest to make. Paul Cadman noted that he had a conflict of interest in relation to ST0813 L7 Senior Leader Professional because he is a director and shareholder of an Independent Training Provider (ITP) which submitted a quote as part of the funding band recommendation process. The same ITP also employs the chair of the trailblazer group. It was therefore agreed that he would not take part in the discussions for this funding band decision. No other conflicts of interest (actual or potential) were declared. All



committee members recognised that should a potential or actual conflict arise by virtue of their other interests (outlined in the declaration of interests) then it must be raised at the outset of the relevant meeting which deals with the issue giving rise to the actual or potential conflict.

3. Covid Update

IV. The committee welcomed the Institute keeping EPA flexibilities in place and under review especially given the second wave of the pandemic. In addition, the committee drew on experiences on how their own organisations had adapted to Covid-19 restrictions and in particular return to office work.

4. T Level content

- V. The committee agreed that the correct processes had been followed to assure the content of the Wave 2 technical qualifications in Digital, Construction and Health and Science, subject to the awarding organisations addressing some minor assessment issues.
- VI. The committee agreed the outline content structure for the Craft & Design pathway and requested to see the outline content at the earliest opportunity.

5. Higher Technical Qualifications update

- VII. The committee was updated on the progress of the approval process for higher technical qualifications (HTQs) on the digital route.
- VIII. The committee noted that qualifications need to hold currency with all stakeholders, including students and providers, and must be aligned to the needs of industry.

IX. The committee were updated on the funding band review in the Health and Social Care route.

X. The committee were updated on overview of the pre-proposal process and the changes being made. This would allow the Institute the to provide more support to the trailblazer on development of technical education products early.

XI. The committee reviewed 3 recommendations on new occupation proposals made by Route Panels in Cycle 31. The committee agreed with all the recommendations made.

In relation to ST0442 L2 Stonemason and ST0264 L2 Carpentry and Joinery, the committee requested an early review to consider take up.
